## No 35/2024

# Amending the Governing Board Decision No 14/2023 on the selection of the Hosting Entities for the Mid-Range Supercomputers (Amendment No 1)

THE GOVERNING BOARD OF THE EUROHPC JOINT UNDERTAKING,

Having regard to Council Regulation (EU) 2021/1173 of 13 July 2021 on establishing the European High Performance Computing Joint Undertaking and repealing Regulation (EU) 2018/1488<sup>1</sup>, (hereinafter, "the JU Regulation"), in particular Article 9, 10 and 14 thereof,

Having regard to Statutes of the European High Performance Computing Joint Undertaking annexed to the JU Regulation (thereinafter "JU Statutes") and in particular to Articles 6(4) and 7(4)(d) thereof,

Having regard to the Governing Board Decision No 14/2023 of 15 June 2023 on the selection of the Hosting Entities for the Mid-Range Supercomputers,

Having regard to the Governing Board Decision No 33/2022 of 25 November 2022 adopting the amended EuroHPC Joint Undertaking Work Programme and Budget for the year 202 (Work Programme and Budget Amendment No 4)<sup>2</sup>,

### **WHEREAS**

(1) By means of the Governing Board Decision No 14/2023 of 15 June 2023, the Governing Board of the EuroHPC Joint Undertaking approved the selection of Linköping University as a Hosting Entity for a EuroHPC JU Mid-Range Supercomputer (Arrhenius Mid-Range Supercomputer),

- (2) The Hosting Entity informed the EuroHPC Joint Undertaking about its intention to adjust the budgets allocated to acquisition costs and operating costs. The total costs of ownership remain the same as approved by the Governing Board Decision No 14/2023 of 15 June 2023.
- (3) In line with Article 17(2) of the JU Regulation, the share of Union's access time to each Mid-Range supercomputer shall be directly proportional to the financial contribution of the Union to the acquisition and operating costs of supercomputer and shall not exceed 35% of the total access time.
- (4) The proposed adjustment between the acquisition and operating costs from the contribution of the Participating State in which the Hosting Entity is located will not affect the percentage of the Union's financial contribution. Thus, the Union's access time will remain unchanged.

### HAS ADOPTED THIS DECISION:

### Article 1

The Governing Board approves the adjustment of budgets allocated to the acquisition costs and operating costs of the Arrhenius Mid-Range Supercomputer. The maximum acquisition costs shall be EUR 47,097,600.00. The maximum operating costs shall be EUR 21,442,400.00.

The maximum total costs of ownership remain the same as approved in the Governing Board Decision No 14/2023 of 15 June 2023.

### Article 2

Other provisions of the Governing Board Decision No 14/2023 of 15 June 2023 remain unchanged.

### Article 3

This Decision shall enter into force on the date of its adoption.
