

# EuroHPC JOINT UNDERTAKING DECISION OF THE GOVERNING BOARD OF THE EuroHPC JOINT UNDERTAKING

# No 34/2024

Approving the launch of the call for tenders for the acquisition, delivery, installation and hardware and software maintenance of EuroQCS-Italy quantum computer for EuroHPC Joint Undertaking

THE GOVERNING BOARD OF THE EUROHPC JOINT UNDERTAKING,

Having regard to Council Regulation (EU) 2021/1173 of 13 July 2021 on establishing the European High Performance Computing Joint Undertaking and repealing Regulation (EU) 2018/1488<sup>1</sup>, (hereinafter, "the Regulation"), in particular Article 12 thereof,

Having regard to the Statutes of the European High Performance Computing Joint Undertaking annexed to the Regulation (thereinafter "Statutes") and in particular to Articles 1(i), 6(5) and 7(4) (f) thereof,

Having regard to the Council Regulation (EU) 2024/1732 of 17 June 2024 amending Regulation (EU) 2021/1173 as regards a EuroHPC initiative for start-ups in order to boost European leadership in trustworthy artificial intelligence<sup>2</sup>,

Having regard to the Governing Board Decision no 41/2022 of 5 December 2022 amending the Joint Undertaking's Work Programme and Budget for the year 2022 (Amendment No 5),

Having regard to the Governing Board Decision no 27/2022 on the selection of the Hosting Entities for the European quantum computers integrated in HPC supercomputers,

### **WHEREAS**

- (1) The Joint Undertaking shall procure the quantum computers and it shall own them.
- (2) By Decision no 27/2022 of 3 October 2022, the Governing Board selected the consortium coordinated by Consorzio Interuniversitario Cineca (hereinafter 'Cineca') as Hosting Entity for the EuroHPC quantum computer (EuroQCS-Italy).
- (3) The European High Performance Computing Joint Undertaking and the Hosting Entity, Cineca, signed the Hosting Agreement no 04/2023, dated 14 June 2023, for the provision of the facilities to host and operate an EuroHPC quantum computer and the provision of the hosting services.
- (4) The amendment of the Work Programme and Budget of the EuroHPC Joint Undertaking for the year 2022, has been adopted by the Governing Board by its Decision no 41/2022 of 5 December 2022 (Amendment no 5).
- (5) In order to avoid the risk of double-funding, the Contracting Authority and the Hosting Entity shall, as required by the Commission, ensure proper implementation of the procurement with relation to different funding programmes, including the Digital Europe Programme (DEP) and Recovery and Resilience Facility (RRF), in particular in light of Article 9 of RRF Regulation<sup>3</sup> and Article 23 of DEP Regulation<sup>4</sup>.
- (6) The Governing Board shall approve the launch of the call for tenders, in accordance with Annual Work Programme 2022.
- (7) The Executive Director of the EuroHPC Joint Undertaking should manage the call for tenders as provided for in Annual Work Programme 2022,

## HAS ADOPTED THIS DECISION:

#### Article 1

The Governing Board hereby approves the launch of the call for tenders for the acquisition, delivery, installation and hardware and software maintenance of EuroQCS-Italy quantum computer for EuroHPC Joint Undertaking following an open procurement procedure in

accordance with the Work Programme and Budget of the EuroHPC Joint Undertaking for the year 2022, and within the available budget in accordance with the Budget of the Joint Undertaking for 2022, on the basis of the procurement documents annexed to this Decision and invites the Executive Director to take all necessary actions in this regard.

### Article 2

The Call for Tender shall be published at least:

- on the website of the EuroHPC Joint Undertaking;
- in the Official Journal of the European Union (OJEU)
- Funding & Tender opportunities Portal.

# Article 3

This Decision shall enter into force on the date of its adoption.
