

# DECISION OF THE GOVERNING BOARD OF THE EuroHPC JOINT UNDERTAKING No 20/2019

#### of 13 November 2019

## on types of post and post titles in EuroHPC JU

### THE GOVERNING BOARD,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS') laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup>, and in particular Article 5 of the Staff Regulations and Annex I thereto, and Article 10 of the CEOS.

Having regard to Council Regulation (EU) 2018/1488 of 28 September 2018 establishing the European High Performance Computing Joint Undertaking<sup>2</sup> (hereinafter 'EuroHPC JU'),

Having regard to the agreement of the European Commission pursuant to Article 110(2) of the Staff Regulations C(2018) 8800 final of 11 December 2018,

After informing the staff,

#### Whereas:

- 1) On 10 April 2019, the Commission informed EuroHPC JU that it adopted Decision C(2013)8979 of 16 December 2013 on types of post and post titles.
- 2) On 26 September 2014 Communication C(2014) 6543 from Vice-President Šefčovič to the Commission on the guidelines on the implementation of Article 110(2) of the Staff Regulations with regard to the implementing rules applicable in the agencies was adopted, and in particular Point 2.B thereof, where the Commission ex ante agreement is referred to.
- 3) Pursuant to Article 110(2) of the Staff Regulations, implementing rules such as those referred to in Recital 1 are to apply by analogy to EuroHPC JU. By way of derogation, an agency may request the Commission's agreement to the non-application of certain implementing rules. The Commission may, instead of accepting or rejecting the request, require the agency to submit for its agreement implementing rules which are different from those adopted by the Commission.
- 4) Commission Decision C(2013)8979 is suitable to apply to EuroHPC JU provided that certain adjustments are made to take into account the peculiarities of the EuroHPC JU. Those adjustments concern in particular the terminology established in the EuroHPC

JU to describe functions exercised, the range of grades of Head of Department post title of which the lower grade should respect the limitation referred to in Article 53 of the CEOS and the range of grades within other types of post.

- 5) For each of the three function groups (AD, AST and AST/SC), the types of post with the corresponding grade ranges are laid down in Annex I to the Staff Regulations.
- 6) It is necessary to establish the equivalence between these types of post and the post titles which are used for EuroHPC JU temporary staff,

#### HAS DECIDED AS FOLLOWS:

#### Article 1

In accordance with Article 5(4) of the Staff Regulations, the tables establishing the equivalence between the types of post and the post titles used for EuroHPC JU temporary staff, which are contained in the Annex to this Decision, are hereby approved.

#### Article 2

Commission Decision C(2013) 8979 of 16 December 2013 does not apply by analogy to EuroHPC JU.

#### Article 3

This Decision shall take effect on the day following that of its adoption.

# A. Types of post

Type of post	Function group / Grade	Post title
Director <sup>3</sup>	AD 14 – AD 15	Executive Director
Adviser or equivalent	AD 13 – AD 14	Adviser Senior Expert
Head of Unit or equivalent	AD 9 – AD 14	Head of Unit Head of Department <sup>4</sup>
Administrator	AD 5 – AD 12	Principal Administrator or Senior Programme Officer <sup>5</sup> Administrator or Programme Officer <sup>6</sup>
Senior Assistant	AST 10 – AST 11	Senior Assistant
Assistant	AST 1 – AST 9	Assistant <sup>7</sup>
Secretary/Clerk	SC 1 – SC 6	Secretary/Clerk

This is without prejudice to a different classification of the head of the agency according to the founding regulation and/or the establishment plan.

Posts of Head of Department are filled from grades AD 12 to AD 14.

Posts of Principal Administrator are filled from grades AD 9 to AD 12.

Posts of Administrator are filled from grades AD 5 to AD 9.

Posts of Assistant are filled from grades AST 1 to AST 9.
