**DECISION OF THE GOVERNING BOARD OF THE EuroHPC JOINT**  
**UNDERTAKING No 20/2025**  
**Approving the launch of a call for proposals on HPC Centres of**  
**Excellence and HPC Lighthouse Codes**

THE GOVERNING BOARD OF THE EUROHPC JOINT UNDERTAKING,

Having regard to Council Regulation (EU) 2021/1173 of 13 July 2021 on establishing the European High Performance Computing Joint Undertaking and repealing Regulation (EU) 2018/1488<sup>1</sup>, as amended by Council Regulation (EU) 2024/1732 of 17 June 2024 amending Regulation (EU) 2021/1173 as regards a EuroHPC initiative for start-ups in order to boost European leadership in trustworthy artificial intelligence<sup>2</sup>, (hereinafter, "the Regulation"),

Having regard to the Statutes of the European High Performance Computing Joint Undertaking annexed to the Regulation (thereinafter "Statutes") and in particular Articles 1(i) and 7(5)(c) thereof,

Having regard to Decision of the Governing Board of the EuroHPC Joint Undertaking No 19/2025 of 7 May 2025, amending the Joint Undertaking's Work Programme and Budget for the year 2025 (Work Programme and Budget Amendment No 3),

WHEREAS

- (1) The Joint Undertaking's Work Programme and Budget for the year 2025 was amended by means of Governing Board Decision no 19/2025 of 7 May 2025 (Amendment No 3).
- (2) The Governing Board shall approve the launch of calls for proposals in accordance with the annual work plans.
- (3) The Executive Director of the EuroHPC Joint Undertaking should manage the calls for proposals as provided for in the annual work plan, administer the grant agreements and related decisions.

HAS ADOPTED THIS DECISION:

*Article 1*

The Governing Board hereby approves the launch of a call for proposals on HPC Centres of Excellence and HPC Lighthouse Codes in accordance with the amended Work Programme and Budget of the EuroHPC Joint Undertaking for the year 2025, as approved by Governing Board Decision no 19/2025 of 7 May 2025 (Amendment No 3).

The EU-funding rate for eligible costs in grants awarded by the EuroHPC Joint Undertaking for this topic will be up to 50 % of the eligible costs.

*Article 2*

The Executive Director of the EuroHPC Joint Undertaking is hereby instructed to launch a call for proposal on HPC Centres of Excellence and HPC Lighthouse Codes, in accordance with the Work Programme and Budget of the EuroHPC Joint Undertaking for the year 2025, as approved by Governing Board Decision No 19/2025 of 7 May 2025 (Amendment No 3).

The call shall be published at least:

- On the website of the EuroHPC Joint Undertaking;
- On the single portal for participants (Funding and Tenders Opportunity Portal).

*Article 3*

This Decision shall enter into force on the date of its adoption.
